


Get Help! 2-1-1 is an easy-to-remember and universally recognizable telephone number that connects people in need with information and

A total of 3,502 calls were made during the fiscal year of July 2020 to June 30, 2021. ## **Emergency Food & Shelter Program**

Our United Way continues to serve as the administrator for the National Emergency Food and Shelter Program (EFSP). The EFSP is a Federal program administered by the U.S. Department of Homeland Security's Federal Emergency Management Agency. Funding is based on unemployment and poverty rates in our community and helps provide essential emergency food and shelter, and Nash & Edgecombe counties were awarded \$232,197 for Phase 37, Phase 38 & Phase CARES. The EFSP Advisory Board, with Board Chair, Warren Stephenson, oversaw the distribution of these funds to community Local Recipient Agencies that include: A Touch of the Father's Love, Christian Fellowship Home, Michael's Angels Girls Club, My Sister's House, Nash Edgecombe Economic Development, Inc. (NEED), The REACH Center, Ripple Effects, St. Andrews Church, Tarboro Community Outreach, The Mercer Foundation, The Salvation Army, Truth Foundational Ministries, United Community Ministries.

SingleCare (formerly FamilyWize) partners with United Way and 211 to help people afford much-needed prescription medications so they can live happy, health lives. With prescription savings cards, SingleCare is helping individuals who are uninsured, underinsured, or insured by high deductible plans save up to 80% on prescription medications. Since 2005, SingleCare has helped over 21 million people save more than \$2 billion on prescription drug costs.

#### **Community Partnership**

In 2021, the North Carolina SweetPotato Commission (NCSPC) announced their partnership with Ripe Revival, Harrison Family YMCA and United Way to host a first of its kind after-school event. The NCSPC crafted an afternoon of fun for children in which they learned all about everyone's favorite orange superfood.

Hosted at the Harrison Family YMCA, activities focused primarily on sweetpotatoes and included stations featuring information about careers in agriculture, sweetpotato art, and general fun facts about NC sweetpotatoes. Children also had a chance to taste and enjoy a smoothie recipe using NC sweetpotatoes and discuss their powerful nutrition led by Ripe Revival's onsite Registered Dietitian, Sarah Hester MS, RD. And to the delight of children in attendance, the NCSPC's very own mascot, Spencer Sweetpotato, also made an appearance.



# **COVID-19 Relief**

Many would agree that 2020 and 2021 were tumultuous years; with the COVID-19 pandemic, skyrocketing death rate and economic struggle of working class families. Through it all, our local United Way has been a beacon of light for our community in many aspects.

The United Way COVID-19 Fund is a local effort to mobilize funds to help address challenges for our children, families and individuals as a result of COVID-19. Through an efficient and accountable grants process, United Way is working with nonprofit partners to address urgent needs in feeding, housing, individual/ family stability, childcare, and youth, senior & special populations' support, while encouraging innovative programming and community partnerships.

# **NC Governor's Volunteer Award**













The Governor's Volunteer Service Award honors the true spirit of volunteerism by recognizing individuals, groups and businesses that make a significant contribution to their community through volunteer service. Any person, group, or entity from the public, non-profit and private sector may be nominated for an award to their county award coordinator. County award coordinators submit their top 10 volunteer nominations per county. There are categories for the type of nominee (senior, youth, faith-based, family, group, business, etc.). Additional categories are based upon the area of service (animal, environmental, disaster, youth, preservation, etc.). County recommendations are reviewed by the Commission and awards are given out in the counties.

The Governor's Medallion Award for Volunteer Service was implemented in 2006 to recognize the top 20-25 volunteers in the state. Medallion recipients are nominated at the county level by the county award coordinator. Only one Medallion nomination is permitted per county. A statewide panel reviews and evaluates all these nominations to determine the award recipients. Medallion Award recipients are honored at an annual recognition ceremony. The medallion is placed around the neck to signify the volunteer's great service to the community.

In July 2021, United Way hosted a reception to honor the local recipients of the NC Governors' Volunteer Service Awards. The recipients were Dr. Marilyn Malloy Jackson, 2020 Recipient, Kelly Spivey, 2021 Edgecombe Recipient, Delois Mercer, 2021 Nash Recipient, and Nancy Jones Taylor, 2021 Medallion Recipient
