A stroke survivor could not do anything for herself a year before entering into United Community Ministries Shelter Program. She lost everything, her job and her home. When she came to the shelter, she had very low self-esteem and had no confidence in herself. She started helping out around the shelter in the office and kitchen learning responsibility all over again. She later obtained a job and moved out into her own place.

NC 211 PROGRAM



United Way Tar River Region began our local 2-1-1 Program in 2008 after a community-wide needs assessment indicated we needed a free, confidential, 24-hour per day, information and referral (I & R) program that would connect our community members with vital health and human resources. With the idea that information is powerful for our local citizens, we began this program across the twin-counties of Edgecombe and Nash, did all the database research, and partnered with United Way N.C. to access professional and highly trained I & R specialists operating out of a shared call center.

Since then, our local 2-1-1 Program has fielded thousands of calls and website visits that have connected our citizens with needed health and human service supports, increased access to resources & care, improved the health of citizens, and supported those after extraordinary situations, such as COVID-19, the QVC facility fire, and most recently, our July 19th Tornado. A total of 3,677 calls were made during the year of 2024.

Emergency Food & Shelter Program

Our United Way continues to serve as the administrator for the National Emergency Food and Shelter Program (EFSP). The EFSP is a Federal program administered by the U.S. Department of Homeland Security's Federal Emergency Management Agency. Funding is based on unemployment and poverty rates in our community and helps provide essential emergency food and shelter, and Nash & Edgecombe counties. For Phase 41, we awarded funding of \$ 69,241. The EFSP Advisory Board, with Board Chair, Warren Stephenson, oversaw the distribution of these funds to community Local Recipient Agencies for both Phases include: *A Touch of the Father's Love, Christian Fellowship Homes, My Sister's House, St. Andrew's Church, Tarboro Community Outreach, The Mercer Foundation, The REACH Center, The Salvation Army, N.E.W., Truth Foundational Ministries, United Community Ministries.*
